

# Online Manuscript Submissions & Tracking

For editorial offices interested in web-based peer review, Hopkins Press has an agreement with Clarivate **ScholarOne Manuscripts**. Contact Publisher William Breichner at [wbreich1@jh.edu](mailto:wbreich1@jh.edu) for more information.

## Submission Fees, APCs & Open Access

Hopkins Press does not require an article submission fee or article processing charge (APC) to be considered for publication in any of the 100+ journals we publish. Any website that purports to be affiliated with a Hopkins Press journal and that requires payment of an article submission fee is fraudulent and should be reported to Publisher William Breichner at [wbreich1@jh.edu](mailto:wbreich1@jh.edu).

Authors/funders of accepted and published articles in any Hopkins Press journal have the option to pay a US\$3,000 APC to publish the article gold open access (OA), which ensures the article will be freely available in perpetuity at Project MUSE. We also offer cost-free green OA, which allows an author to deposit their accepted manuscript (rather than the final published article) in their noncommercial institutional repository. There is no embargo period for this deposit, which may be made upon acceptance of an article and receipt of the signed publishing agreement. ## What We Do

The Hopkins Press Journals Production Department is your partner in ensuring that issues are produced in adherence to the highest professional standards and economically. We strive to suit your journal's needs in a cost-efficient and flexible way through a variety of services:

- Web-based peer review via Hopkins Press agreement with Clarivate **ScholarOne Manuscripts** (contact Publisher William Breichner at [wbreich1@jh.edu](mailto:wbreich1@jh.edu) for more information about this option)
- Copyediting to various stylebooks
- Cover and interior design
- Typesetting or page layout
- Proof distribution and coordination of corrections
- Printing (offset, digital, print on demand)
- Estimates for special costs (e.g., color inserts, supplements)
- Obtaining USPS permits and preparation of USPS annual statements
- Mailing services, including air freight to subscribers outside the USA
- Warehousing, shipping back issues, and bulk shipments
- Article reprints

All journals published by Hopkins Press are assigned an individual production coordinator to shepherd each issue through the publishing process. Your journal's production coordinator is your main point of contact for most questions about producing the journal, from permissions to schedules, typesetting, and printing.

## Workflow & Scheduling

While the workflow for every journal may vary slightly, there are standard production steps and turnaround times to plan for. From the moment copyedited manuscripts are turned over to your production coordinator, you can expect the following:

- Manuscripts turned over to typesetting (within 2 days)
- 1st page proofs to production coordinator (within 2 weeks)
- 1st page proofs to editors/authors (within 2 days)
- 1st page corrections to production coordinator from editors/authors (within 2 weeks)
- 2nd page proofs incorporating requested changes/corrections to production coordinator (within 1 week)
- 2nd page proofs to editors (within 2 days)
- Final corrections to production coordinator from editors (within 1 week)
- Final corrections made and issue sent to printer (within 1 week)
- The printing process, preflight to mailing (roughly 12 business days)

Ideally, this entire production process takes around 2½ months. Note that if the submitted manuscripts need to be copyedited, that adds a minimum of 1 month to the process, depending on the length and complexity of the issue.

In many cases, these stages do not take as long as outlined, but they are a good guide for busy times. Your production coordinator will try to accommodate special circumstances that require quicker turnarounds—please give as much notice as possible in these cases. The printing process is the only stage where time can never be trimmed.



## Manuscript & Art Preparation

Properly prepared manuscripts and art files facilitate the production process. Refer to our [Manuscript & Art Preparation Guidelines](#) and [Art Log](#) for guidance.

## ORCID

**ORCID (Open Research and Contributor ID)** is a nonprofit organization that assigns unique identifiers to academic researchers, ensuring that your work is recognized and credited to you even though you may publish under different variations of your name, change your name, or just have a common name (e.g., John Smith). The ORCID iD is free, unique, and persistent. Hopkins Press can accommodate ORCID iDs included in manuscripts that are submitted for production, but we will not insert ORCID iDs post-publication.

## Abstracts & Keyword Information

Hopkins Press requires the use of abstracts and keywords for all articles in our journals unless it's a creative work. Editors may choose whether to include abstracts and keywords in print and online or to publish them online only. In either case, you are benefiting your journal:

- Many indexers now pick up their abstract information directly from MUSE pages.
- Readers or potential readers can do research more easily and may subscribe or buy issues when they see abstracts that interest them.
- Web search engines do a much more accurate job of finding and categorizing your publication's contents and will also return better results for each individual author's work.
- Abstracting benefits both authors and editors in making our journals more accessible and useful to the academic community.

In deciding whether to publish abstracts online only or in print and online, consider whether the print journal's design lends itself to inserting abstracts and keywords. Please consult your coordinator and refer to [Online-Only Abstract Submission Guidelines](#).

## Manuscript Submission & File Sharing

Files are shared between editorial offices and Hopkins Press via a Microsoft SharePoint File Transfer site. Each journal has an assigned folder. When transmitting an issue to the Press, place all files in a folder labeled with the journal acronym or name and the volume and issue number, e.g., AJP 10.1. Upload the folder to the Press-assigned SharePoint folder and notify your production coordinator via email that this has been done.

Please notify your production coordinator whenever materials are placed in the SharePoint folder, for assistance using SharePoint, or to authorize additional persons for access to the journal's folder. For detailed filesharing instructions, refer to [Working in Microsoft SharePoint](#).

# Publishing Agreements & Permission Requirements

Publishing agreements and permissions need to be submitted to Hopkins Press at the time of manuscript submission. If an article, image, chart, or other piece of intellectual property has not been cleared by its owner or creator, we will be unable to publish until its legal status has been resolved. As a result, it is imperative that the content you submit includes paperwork or correspondence granting you publishing rights.

- All journal content (articles, reviews, editorials) requires a signed Publishing Agreement (PA) from the author(s). Some PAs are journal-specific, but we've included for your reference a [Sample JHUP Publishing Agreement](#) and a sample [JHUP Pub Agreement for US Government Employees](#). We strongly recommend that you send contributors the publishing agreement form with your acceptance letter.
- Agreements regarding intellectual and creative work tend to be customized to serve the needs of individual journals. See our [JHUP Interview Agreement](#) and [Creative Work Permission Form](#) and check with your production coordinator for more information.
- Permissions for images and charts vary based on their provenance and intended use. For example, an artist or other intellectual property holder may allow you to include work within an article but not as a cover image. It is important to obtain documentation/correspondence that explicitly permits use of the work for a specific purpose. See our standard [Creative Work Permission Form](#).
- Intellectual property from the public domain does not require forms. However, you should provide documentation/correspondence that proves the work's legal status.
- If you are unable to establish a work's legal status or connect with its rights holder despite multiple good faith attempts, please discuss your options with your production coordinator.

## Proofing Process

Typically, each issue of a journal will run through two proofing stages. The first page proofs should be examined by the authors and the editors for any minor corrections of errors that may have been introduced during typesetting. This is not an opportunity to rewrite the manuscript, and requested corrections should be kept to a minimum.

The typesetters will implement first proof corrections and generate a second set of page proofs. This second set of page proofs should be reviewed by the editors (not authors) to ensure that requested corrections were made as intended. Any newly discovered corrections must be kept to the absolute minimum.

Final corrected pages are typically verified by the production coordinator, but if the editorial team would like to view them, just let your production coordinator know.

## Digital Annotation

Hopkins Press has transitioned to a digital process for proof corrections, and we ask that editors use Adobe Acrobat PDF annotation tools to make their corrections directly on the PDFs.

The tools facilitate the correction process and are available as part of all PDFs. No additional software is necessary. The electronic method of marking up corrections is precise:

- insert
- delete
- replace
- sticky note (for sparing use only when additional information needs to be conveyed for more complicated corrections)

Author and editorial office corrections should be consolidated onto one set of annotated proofs for submission to your production coordinator. Mark definitive corrections only, without explanation. Anything you insert, delete, or replace on the PDF will automatically be incorporated into the pages. A sticky note tool is available in rare cases when you need to highlight a correction that is more complex and cannot be easily annotated with the available tools.

If digital annotation is not an option due to special circumstances, please notify your production coordinator, who will work with you to accommodate an alternative.

## Mailing Services

Mailing is the final stage of the process at the printer. Please note that issues are shipped first to journal subscribers. Bulk orders going to your editorial offices or elsewhere are shipped separately a few days after the subscription mailing.

### Contributor & Society Mailing Lists

We require a full name and mailing address for any contributor/society member copies of a journal. PO boxes can only be used with USPS shipping. Society mailing lists are usually supplied by the editorial office in an Excel or Word file (see [Bulk Mailer Template](#)).

If you provide subscriber mailing addresses to your production coordinator, those files are run through the USPS national change of address (NCOA) system, and if any address changes are on file, a new Excel sheet is generated. Your production coordinator will share any address changes with you. Please update your records accordingly. This prevents the USPS from needing to update these addresses with each new mailing.

### Gratis Lists

Editors have the option of sending a limited number of gratis print copies to individuals or organizations and are encouraged to review the journal's gratis list at least once a year. Ask your production coordinator for a copy. Keeping the gratis list updated can save the cost of mailing copies that are no longer needed or wanted.

## Errata

Substantive errors in published articles should be brought to the attention of your production coordinator, who will work with you and the Journals Publisher to determine if an erratum is warranted. Errata become a permanent part of the scholarly record, added to the original article at Project MUSE, appearing in a future print issue, and published as part of that issue online at Project MUSE. Typographical and other minor errors that do not affect the substance of an article will not be corrected in print or online.

## Permission to Reprint or Translate

When authors have questions about using or reprinting their Hopkins Press Journals content, please refer them to the Rights of the Author specified in their publishing agreement and to the Hopkins Press **Permissions Department** if they have further questions. We also have helpful information in the **Hopkins Press Author FAQs**.

## Open Access

Occasionally, an author will want or be required to publish an article open access. Please see **Submission Fees, APCs & Open Access** in the Publisher's Office section of this guide and our **Open Access page** for more information.

## Temporary Digital Access

All Hopkins Press journals always have at least one free issue available on Project MUSE. This is an older issue that is open, or ungated, for the duration of the journal's volume year. Ungated issues serve many purposes, but for editors, they can give authors an idea of your editorial focus, copyeditors a guide to your style, and rights grantors an understanding of your journal and of Project MUSE. Our Marketing Department occasionally ungates journal articles or issues for brief periods (less than 30 days) in conjunction with public relations activities. Marketing can also process requests for brief ungating if you are running a promotion or have a newsworthy item. For details, please see [Temporary Digital Access](#) in the Marketing section. Please be aware that during any period of temporary free access, MUSE-related usage royalties for these articles may be negatively impacted.

## Indexing

## Conference & Event Copies

If you would like additional print copies of an issue for a conference or event, please notify Marketing Specialist Andrea Harney at [aharney1@jh.edu](mailto:aharney1@jh.edu) via email as soon as possible. Please provide the name and date of the event, the address where copies need to be shipped, and how many copies you require. Conference copies must be requested at least six weeks prior to the conference. For new issues, conference copies must be requested at least one month prior to the issue's publication date.

## Subscription Renewals

Renewal notices are sent a maximum of 4 times to individuals who subscribe to the print or electronic versions of our journals. Customers for whom we have a valid email address receive an email notification encouraging online renewal.

- 1st notice: when subscribers receive their second-to-last issue
- 2nd notice: when the subscriber's last issue is mailed and the subscription is complete
- 3rd notice: when the subscriber has missed one issue
- 4th and final notice: 6 to 10 months after the subscription expires, depending on how frequently the journal is mailed

Institutional renewals are generally handled through agents. Those institutions that do subscribe directly with us receive notices twice a year, in March and August. The notices consolidate multiple subscriptions and resemble invoices.

Lapsed subscriber renewals are one-page, personalized notices sent annually to individuals whose subscriptions have expired in the past 6 months to 3 years for a particular journal.

# Manuscript & Art Preparation Guidelines

## Manuscript Preparation

- **File format:** Submit manuscripts as Microsoft Word files in .doc or .docx format.
- **Page setup:** Use document size US 8.5 x 11 or UK A4 with 1-inch margins and hyphenation option turned off.
- **Page numbering:** Place page numbers bottom center, with the title page as page 1. Number all pages sequentially.
- **Paragraphs:** Set double spaced and flush left/ragged right. Indent new paragraphs instead of spacing over or using tabs to indicate an indent.
- **Formatting of type:** Use 12-point, standard (easy to read) font.
- **Subheads:** Differentiate heading levels by including the appropriate <A level>, <B level>, <C level> code next to the heading.
- **Italics:** Set text that you want italicized in italic. Underlined text will be converted to italic unless noted otherwise.
- **Accents and symbols:** Please note any special symbols such as Greek and math at the beginning of the manuscript to bring them to the attention of desktop publishing (DTP). DTP will check page proofs to determine if the symbols converted properly and will make note of instances where they cannot match the character.
- **En- and em-dashes:** Use one hyphen for an en-dash; the typesetter will convert a single hyphen to an en-dash between date and page ranges. For an em dash, use two hyphens with no space before or after the hyphens.
- **Block quotes:** Leave extra space around block quotes and mark each clearly as follows: <ext> to mark the beginning and </ext> to mark the ending.
- **Captions, endnotes, and footnotes:** Type figure captions, endnotes, or footnotes at the end of the manuscript. Use the Microsoft Word endnote feature. Follow the journal style for note numbering (either superscript or regular numbers). Extra line space is not necessary between notes.
- **Works Cited list:** Follow journal style. If there are hanging indents, please use a normal paragraph indent, and the typesetter will apply the correct style.
- **Poetry:** For poetry set as a block quote off from text, indicate line breaks with a hard return. If you cannot fit the entire line of poetry on your typed copy, let the text wrap and indicate the end of the line with a hard return. For poetry set in line with text or notes, use space-slash-space between each line, e.g., “How do I love thee? / Let me count the ways.”
- **Figures:** Include placement markers in boldface, e.g., **<Insert Figure 1 here>**. If you have a sizing request, please specify in the placement marker. If you wish to have figure references typeset, enclose those in parentheses where appropriate, e.g., (Figure 1) or (Fig. 1). Do not include artwork in the manuscript file. See Art Preparation below.
- **ORCID:** If you would like to include your ORCID identifier, please do so in the author byline or author bio section of a manuscript.
- **Abstract & keywords to publish in the print journal:** Submit the abstract and keywords in that order on the manuscript title page, following the title and author name(s). Label “Abstract” and “Keywords,” respectively. (For abstracts and keywords publishing online only, refer to **Online-Only Abstract Submission Guidelines**.)
- **File naming:** Label files in numerical order according to place in the table of contents, volume and issue number, and the contributor’s last name, e.g., 02\_10.1\_Smith. Cover and front matter file names, e.g., 00\_10.1\_Covers and 01\_10.1\_FM.
- **AVOID** word-processing style sheets, underlining of headings, drop caps, use of color for text, and coding from bibliographic software like EndNote and Reference Manager. If you use these systems for your references, save a version of your manuscript without coding and submit the uncoded version for publication.

## Art Preparation

- **File format:** Submit images as TIFF (preferable), EPS, or JPEG files.
- **Resolution:** Full color/grayscale (continuous tone) images require 300 dpi resolution. Line art requires 1200 dpi resolution. A good rule of thumb is that a black and white photo should be at least 1 MB.
- **Color:** If the image will print in color, please submit as CMYK. If an image is supplied in color but prints grayscale, we will retain the color version for online publication on Project MUSE.
- **Sizing:** Image size should be the approximate size it will print.
- **Art Log:** Complete an Art Log<sup>10</sup>. Art Log<sup>10</sup> for submission with the issue.

## File Naming Conventions

When submitting a ZIP file or folder of manuscripts for an issue, it is best practice to number each article to reflect the order of the issue's Table of Contents. Images and charts related to each article should share the same number as the article itself. Meanwhile, non-article content should be preceded by the number "00" (e.g., "00\_Cover" or "00\_TOC"). A sample list:

Numbering files in this fashion allows our team to more easily double-check permissions and perform other pre-production tasks. # Online-Only Abstract Submission Guidelines

## Johns Hopkins University Press Journals Division

Following are general guidelines for submitting abstracts and keywords that will publish on Project MUSE only. Some journals have more specific requirements for online-only abstract submission. Please contact your production coordinator about any requirements for your journal.

- Please submit your online-only abstracts with the manuscripts if possible, and *with the first proofs at the latest*.
- One hundred or fewer words is preferred. Editor should choose whether to capitalize or lowercase keywords to be consistent, except for proper nouns.
- Gather all abstracts for an issue in one Microsoft Word file. Please do not send each abstract as a separate file. Organize the abstracts in table of contents order.
- Please name the file with the journal's acronym, volume, and issue number, e.g., CHY\_70.4\_Abstracts. Please save the final file as a PDF.
- Elements should be organized in this order with a line space between items:
  1. author
  2. title
  3. abstract
  4. keywords (if used)
- The author and title are for ID only; surname and short title are fine (e.g., “Smith – Problems of Interpreting Faulkner”).
- Use italic type to indicate italics, not underlines.

## PUBLISHING AGREEMENT

Johns Hopkins University, represented by Johns Hopkins University Press (the Press), shall consider publishing your contribution to *JOURNAL TITLE* (the Journal), entitled \_\_\_\_\_ (the Article).

Should the Press decide to publish the Article in the Journal, you, as Author of the Article, hereby grant and transfer exclusively to the Press all rights of whatever kind to the Article, including but not limited to copyright, during the full term of copyright in the United States of America and elsewhere. The Press will register copyright to the Journal issue in which the Article appears.

**Rights of the Author:** You have the following nonexclusive rights: (1) to use the Article in your own teaching activities; (2) to publish the Article, or permit its publication, as a part of any book you may write or edit; (3) to include the Article in your own personal or departmental institutional database or online site; (4) to include the Article in your institutional repository provided the repository is institution specific and not a discipline-based database that accepts contributions from outside the institution; (5) to include your Article, *if required by law*, in an open access archive such as PubMedCentral. All online posting uses (3, 4, 5) are granted for the final manuscript version of the Article only, not the final published version in any format, including PDF. For all rights granted in this paragraph you agree to credit the Press as publisher and the copyright holder as follows:

Copyright © <year> Johns Hopkins University Press. This article first appeared in *JOURNAL TITLE*, Volume <#>, Issue <#>, <Month>, <Year>, pages <#-#>.

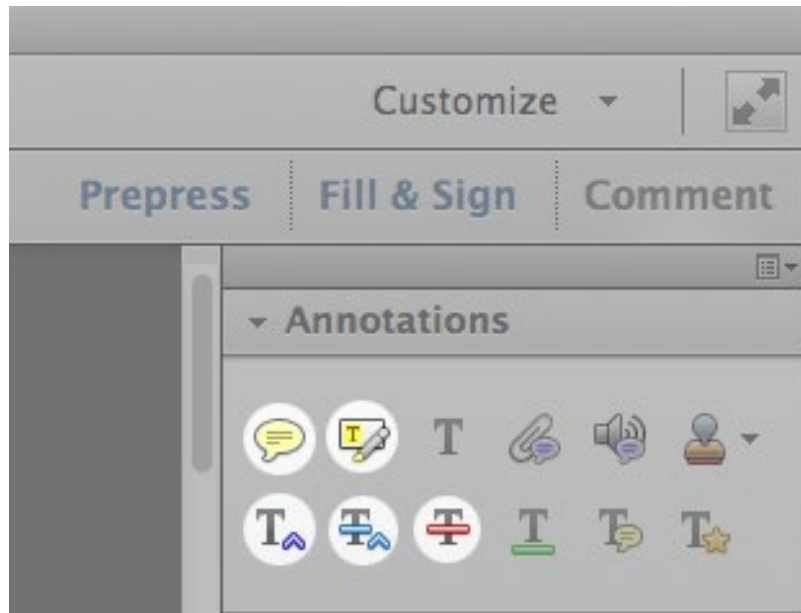

## Working with Adobe Reader & Acrobat

1. Begin by making sure you have Adobe Acrobat XI (either the free Reader, or the Standard or Pro version will do). Adobe Acrobat Reader XI can be downloaded for free here: <http://www.adobe.com/products/reader.html>
2. Open the Comments Tools and select the Annotations Panel.
3. There are 12 tools available in the Annotations Panel, but most text edits will be done with the Insert Text Tool, Replace Text Tool, and Strikethrough Tool. On occasion, the Sticky Note Tool and Highlight Text Tool can help further clarify corrections but should be used sparingly.



- **Insert Text Tool** indicates new text you want inserted into the text. Select this tool, click where you want new text to appear and type the new text into the Comment Window. A blue arrow will indicate where the new text will appear. Be mindful of surrounding spaces in the text and in your new text.
- **Replace Text Tool** replaces text that is already in the document. Select this tool, highlight the word or words you want replaced, and type the new text into the Comment Window. A blue strikethrough line will indicate the text that is being replaced, and a blue arrow will indicate where the replacement text will appear. Be mindful of surrounding spaces in the text and in your replacement text.
- **Strikethrough Tool** deletes text. Select this tool and highlight the text you want deleted. A red strikethrough line will appear over the deleted text. Be mindful of leading or trailing spaces.

- **Highlight Tool** is used to indicate a change of font style, such as roman to italic. Using the Highlight Tool, select the text to be changed, then right-click to show the contextual menu and select “Open Pop-Up Note” and write in the correct font style (i.e., “italic”).
- **Sticky Note Tool** is used to indicate changes to the layout. Select this tool, click on the page where you want your note to appear, and write your instructions (e.g., “Move this image to next page” or “Add a line space above this paragraph”).

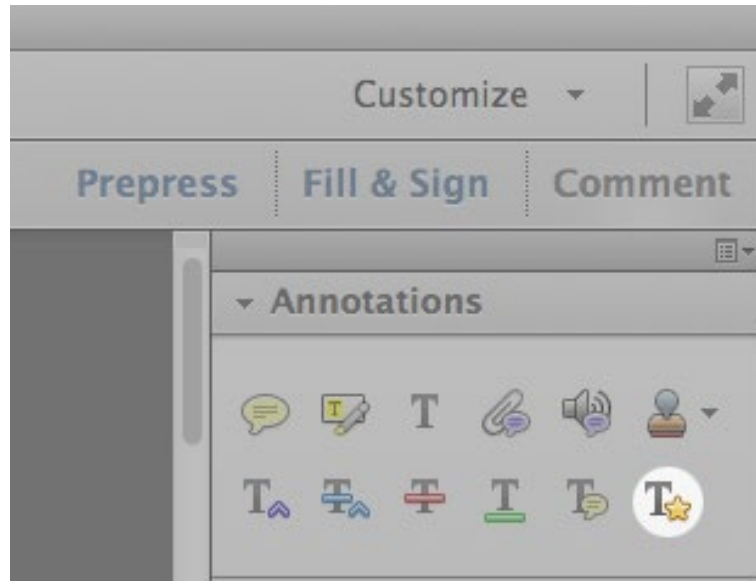
In addition to the Sticky Note Tool to indicate layout changes, the Drawing Markup Tools (located in the Drawing Markups Panel below the Annotations Panel) may be used to draw shapes on the PDF, but please use these tools sparingly, as they will quickly overwhelm the page.

4. After you have finished editing, save the PDF in a recognizable way, such as by adding “\_EDITED” to the end of its name.

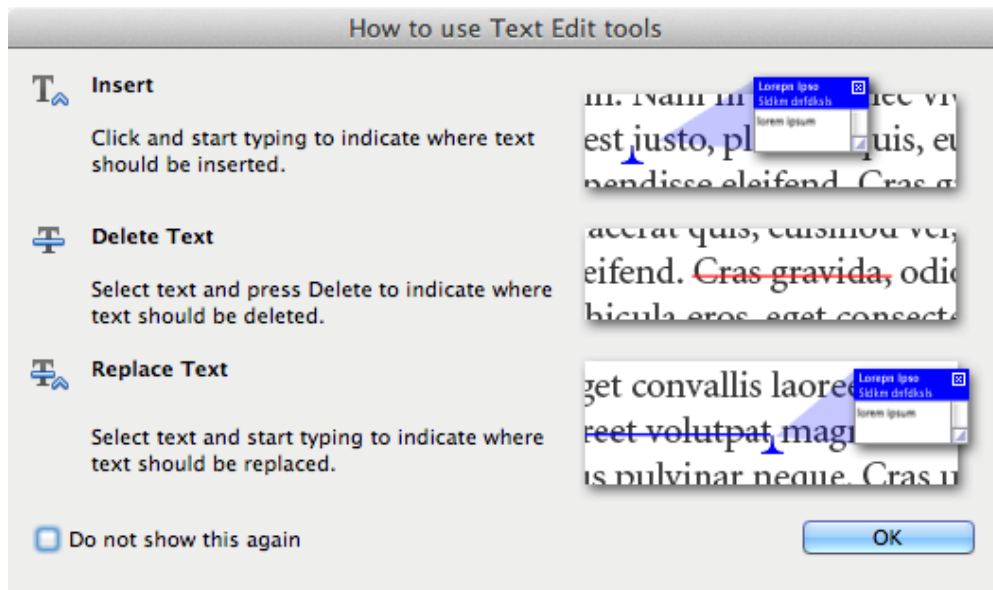
5. Maintain separate PDF files for each article; however, if book reviews are separate, please put them back together in one big book review section before sending back to Hopkins Press. Never add/remove pages from the PDF, even if pages are blank or have no edits. This is important for the import process to work correctly for the person handling the page layout.

## PDF Annotation Tips

- Keep in mind that with all annotation tools, you can right-click for the contextual menu and select “Open Pop-Up Note” to add a note to the tool. For instance, on a page with many images, you could use the Arrow Tool to point to the specific image and add a Pop-Up Note to the Arrow indicating the move, rather than adding a separate Sticky Note. This will help cut down the clutter.
- The Text Correction Tool in the Annotations Panel acts like the Insert Text Tool, Replace Text Tool, and Strikethrough Tool all at once!



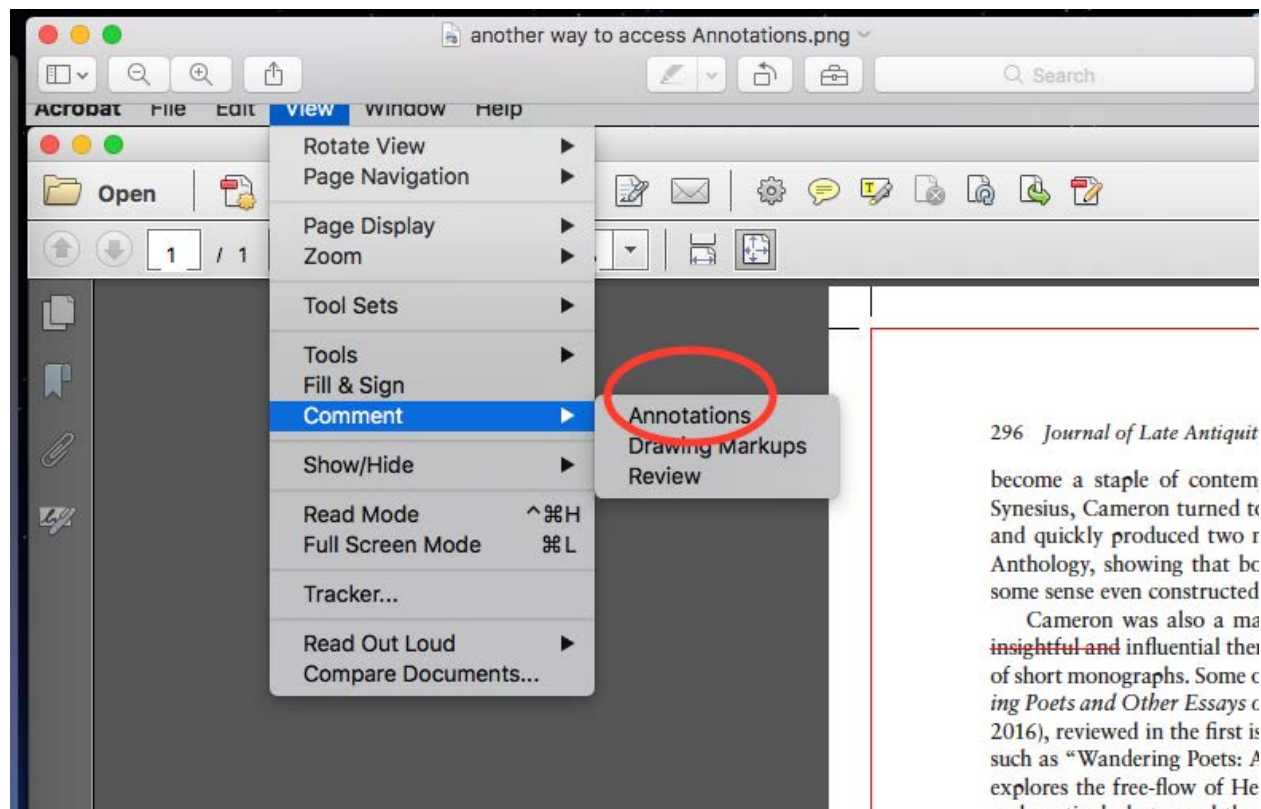

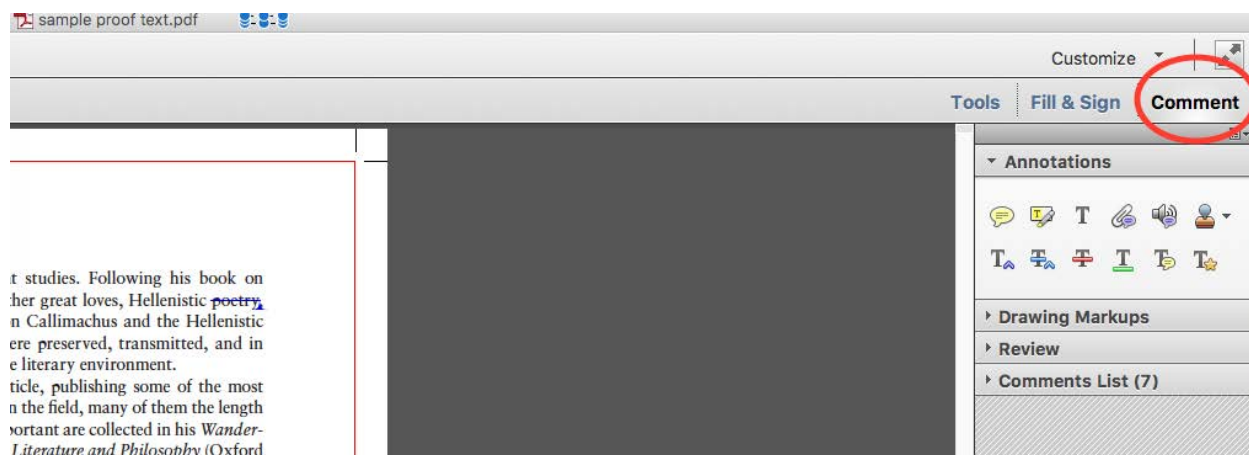
## Annotations Q&A for Editors & Proofreaders

difficult to summarize its vast erudition as it is to estimate its lasting impact, for the work was an instant classic and will remain standard reading for students and scholars for decades to come. A study of the literature and history of Rome's fourth and fifth-century pagans, it surveys and expands upon many of Cameron's long-treasured ideas: about the fundamentally literary nature of pagan-Christian disputes in the period; about the date and authorship of the *Camern contra paganos*; about the insignificance of the fabled *Annales* of Virius Nichomachus Flavianus. The book has won approval from most, provoked aspersions from few, and elicited admiration by all. Standing as a monument not just to all that Cameron thought and achieved but also to an entire generation of scholars steeped in the Classics but eager to look through and beyond them to the rich and rewarding texts of later centuries, it will remain a guidepost for future generations and a signpost of a scholar's life well lived.

This issue also marks the end of my tenure as General Editor of the *Journal of Late Antiquity*. Beginning in January 2018, this position will be assumed by my former University of Colorado Classics colleague Andy Cain. 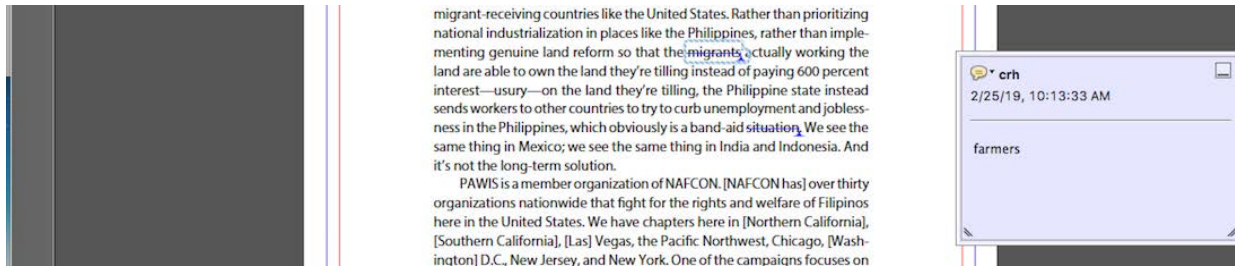

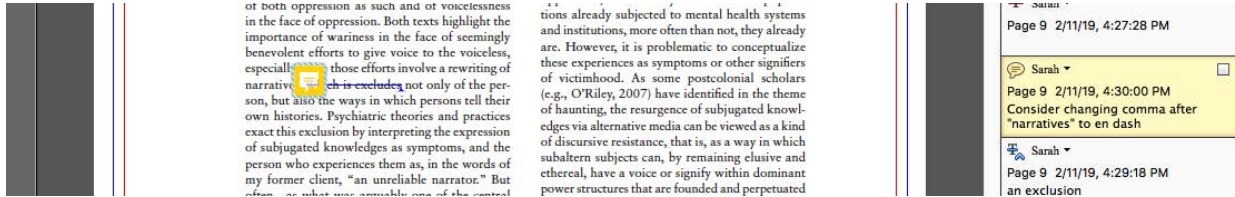

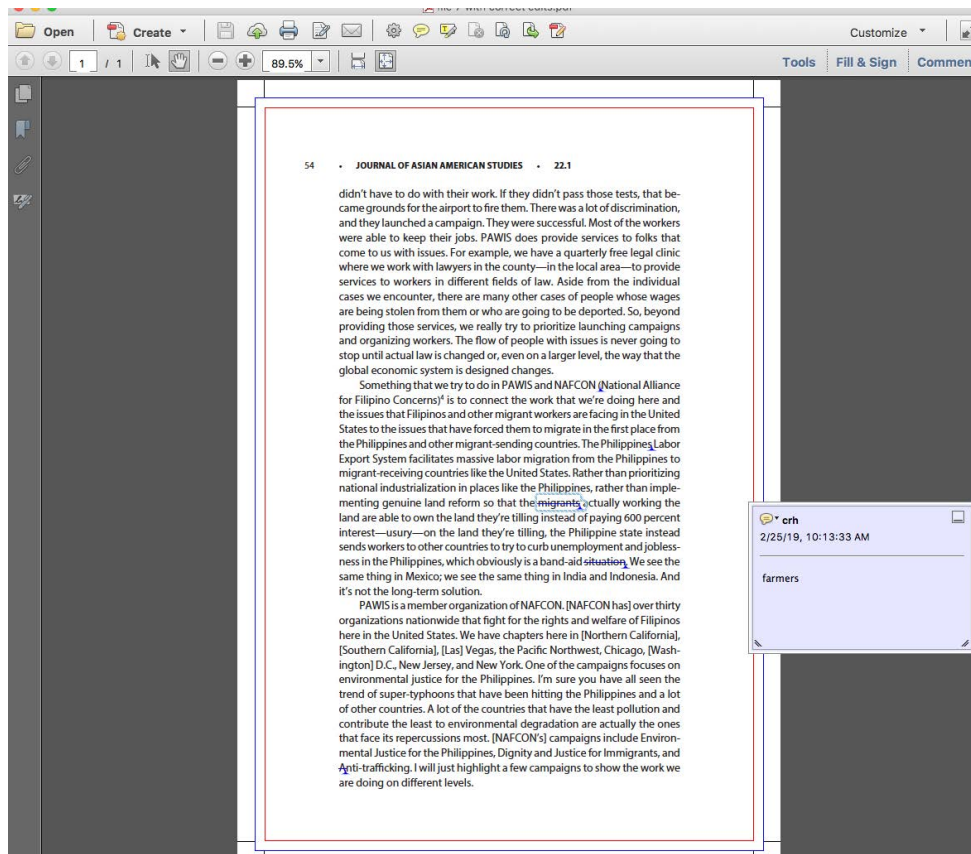

didn't have to do with their work. If they didn't pass those tests, that became grounds for the airport to fire them. There was a lot of discrimination, and they launched a campaign. They were successful. Most of the workers were able to keep their jobs. PAWIS does provide services to folks that come to us with issues. For example, we have a quarterly free legal clinic where we work with lawyers in the county—in the local area—to provide services to workers in different fields of law. Aside from the individual cases we encounter, there are many other cases of people whose wages are being stolen from them or who are going to be deported. So, beyond providing those services, we really try to prioritize launching campaigns and organizing workers. The flow of people with issues is never going to stop until actual law is changed or, even on a larger level, the way that the global economic system is designed changes.

Something that we try to do in PAWIS and NAFCON (National Alliance for Filipino Concerns)<sup>2</sup> is to connect the work that we're doing here and the issues that Filipinos and other migrant workers are facing in the United States to the issues that have forced them to migrate in the first place from the Philippines and other migrant-sending countries. The Philippines Labor Export System facilitates massive labor migration from the Philippines to migrant-receiving countries like the United States. Rather than prioritizing national industrialization in places like the Philippines, rather than implementing genuine land reform so that the migrants actually working the land are able to own the land they're tilling instead of paying 600 percent interest—usury—on the land they're tilling, the Philippine state instead sends workers to other countries to try to curb unemployment and joblessness in the Philippines, which obviously is a band-aid situation.
